Selection of roads under PMGSY

- (a) the criterion for selection of roads under the Pradhan Mantri Gram Sadak Yojana and whether all the 22 roads in Sultanpur District have been selected according to that criterion;
- (b) whether Government are aware that influential people of the districts succeed in inclusion of less important roads in the said Scheme whereas more important roads such as Galibaha—Chamurakha—Jafarpur road with canal route are still to be sanctioned by the district panchayat; and
- (c) whether Government propose to issue instructions to the concerned authorities to include the said roads in the scheme which is beneficial to 15-20 villages?

Induction of Sukhoi 30 MKI jets into the IAF
