Ban on smoking scenes in films

- (d) whether the above directive to black-out tobacco scenes is unworkable and it has also been opposed by the Film Industry; and
- (e) if so, the alternative measures being considered by Government in this regard?

- (a) whether it is a fact that AICTE has reduced 1,220 MCA seats and about 4,000 Engineering seats in Andhra Pradesh;
 - (b) if so, the reasons therefor; and
- (c) the academic year from which the reduction would be operational?

Regularization of illegal colonies in Delhi

Setting up of FM radio stations

- (c) if so, to what extent these Fast Track Courts have been helpful in reducing the burden of long pending cases in the High Courts?

Child education
