# Environmental clearance to Balachaur-Hoshiarpur-Dasuya highway

- \*41. SHRI VARINDER SINGH BAJWA: Will the Minister of ENVIRONMENT AND FORESTS be pleased to state:
- (a) whether a proposal sent by the Punjab Government for removing/cutting of trees for upgradation of the Balachaur-Hoshiarpur-Dasuya highway is pending for environmental clearance;
- (b) if so, since when the request is pending; and
- (c) by when, the clearance is likely to be accorded?

# Commissions/Committees on rail accidents

- \*42. SHRI ABU ASIM AZMI: Will the Minister of RAILWAYS be pleased to state:
- (a) whether it is a fact that Government has decided to set up a special commission/ committee to find out the reasons/causes of rail accidents;

(c) when the reports of the Commissions/Committees are expected to be received by Government?
