#### Contract engineers in EIL

- \*1. SHRI GOPALSINH G. SOLANKI: Will the Minister of PETROLEUM AND NATURAL GAS be pleased to refer to answer to Unstarred Question 1802 given in the Rajya Sabha on the 7th August, 2001, and state:
- (a) whether 50 per cent of vacancies/ requirements of management trainees will be filled on an annual basis from contract engineers as decided by the Board of Engineers India Limited (EIL);
- (b) if so, the number of contract engineers who have been recruited/absorbed by the management of EIL as on 31st January, 2002 and if not, the reasons for delay in re-instating these contract engineers; and
- (c) whether Government would absorb all the contract engineers within a timebound programme and if not, the reasons therefor?

# Deposits with commercial banks

- \*2. SHRI C.O. POULOSE: Will the Minister of FINANCE be pleased to state:
- (a) whether there has been a sharp decline in deposits with the scheduled commercial banks;

- (b) whether the fall in deposits is direct impact of recent decision to cut down the interest rates on deposits; and
- (c) if so, whether Government would reconsider the interest structure in these banks in order to attract more deposits?

#### VRS for Associate Banks of SBI
