- (c) whether Government would take any action on the findings of the Tarapore Committee in this regard; and
- (d) if so, the details thereof and if not, the reasons therefor?

Review of LNG projects

- (d) if so, the details thereof and what steps Government have taken to curb the circulation of fake currency notes in the market?

RBI concern over Government finances

- (a) whether the Reserve Bank of India has voiced serious concern over the deteriorating Government finances in general and State Government finances in particular;
- (b) if so, whether the Bank has noted that the combined debt has touched a high of 69.9 per cent of GDP in 2001-2002 from 61.7 per cent in 1990-1991 and on this, the States' debt-to-GDP ratio, which was at a low of 19.4 per cent in 1990-1991, has risen sharply to 25.6 per cent in 2001-2002;
- (c) if so, what is Government's reaction thereto: and
- (d) what steps are being taken in this regard?

Reduction of air fares by IA/AI

- *118. SHRI AIMADUDDIN AHMED KHAN (DURRU): Will the Minister of CIVIL AVIATION be pleased to state:
- (a) whether recently there ensued a cut throat competition of offering reduced fares for air journys on various popular routes;

- (b) if so, by what percentage did the Indian Airlines and Air India under-cut the fares, and what were the comparative figures of fare cuts offered by different private airlines, during July to October, 2002; and
- (c) the extent to which the possible loss due to vacant space on flights has been made good thereby?

IOC's retail outlet in Centaur Hotel premises

- *119. SHRI DIPANKAR MUKHERJEE: Will the Minister of PETROLUM AND NATURAL GAS be pleased to state:
- (a) whether IOC had a retail outlet in the Centaur Airport Hotel's premises;
- (b) whether the same is on the land leased by the Airports Authority of India;
- (c) whether the same has been transferred to the new promoter by Hotel Corporation of India during disinvestment;

- (d) if so, whether valuation of the same was done by IOC and ownership changed with its consent; and
 - (e) if not, the reasons therefor?

Losses suffered by BRPL

- (a) whether it is a fact that Bongaigaon Refinery and Petrochemicals Limited (BRPL) has been running in loss;
- (b) if so, the losses suffered by it during the last three years and the reasons therefor;
- (c) what has been the capacity utilisation of both the units *viz.*, refinery and petrochemicals during the last three years; and
- (d) the steps being taken to improve the functioning of BRPL and wipe out losses?
