#### Disinvestment of PSUs

\*141. SHRI BHAGATRAM MANHAR: SHRI RAJU PARMAR:

Will the Minister of DISINVESTMENT be pleased to state:

- (a) whether Government's attention has been drawn to the news-item captioned 'Politics stalled NALCO sale' which appeared in the 'Hindustan Times', dated the 2nd November, 2002;
- (b) whether disinvestment process of NALCO, EIL, RCF, Neyveli Lignite Corporation Limited and BEML are being delayed, deliberately; and
- (c) if not, the reasons for not moving fast on the disinvestment of the above PSUs?

#### Private employment exchanges

- (c) if so, the steps taken by Government to stop cheating of the unemployed persons by these private employment exchanges; and
- (d) if no action has been taken, so far, the reasons therefor?

found in possession of the money paid by the Pakistan High Commission;

- (c) whether Government have expelled all such members of the Pakistani High Commission who were held responsible;
- (d) if so, whether Pakistan has protested on this issue; and
- (e) what steps Government have taken against Pakistan on this issue?

  - (c) Government's response thereto?

## Accidents on National Highways

- (d) the steps being taken to prevent such accidents?

#### Packing of drinking water

- (d) what decision has been taken to meet the situation; and
- (e) to what extent this decision has helped in improving the vanaspati units in the country?

### High security registration plates
