## Surrender policy of Government for militants

\*41. SHRI S.S. AHLUWALIA: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) the surrender policy of Government for members of militant/terrorist outfits who eschew violence and intend to return to the mainstream civil society;
- (b) whether it is uniform in all the affected States or is at variance from one State to another;
- (c) whether distinctions, if any, are made between surrendering members belonging to outfits which have been operating at the behest of or linked to foreign espionage agencies and those who took to arms in pursuance of extremist ideological doctrines and/or to fight against policies of Government perceived to be unjust;
  - (d) if so, the details thereof; and
  - (e) if not, the reasons therefor?

### Threat of terrorist attacks

- (a) whether Government are aware of the threat of terrorist attacks on national monuments and temple townships; and
- (b) the steps proposed to meet the threat and protect places of national importance and religious worship?
