- (c) what are the other subjects discussed and the agreements signed during the Prime Minister's visit;
- (d) whether the E.U. had asked India to hasten project approvals;
- (e) whether India and E.U. have set an ambitious target of Euro 35 billion bilateral trade by 2005 which would be stepped up to Euro 50 billion by 2008; and
- (f) if so, to what extent India and E.U. have decided to improve trade relations?

#### New cultural centres

- (a) whether in order to promote India's foreign policy, Government have since decided to open new cultural centres;
