Scheme for Boys Hostels

- *481. SHRI SANTOSH BAGRODIA: Will the Minsiter of TRIBAL AFFAIRS be pleased to state:
- (a) whether it is a fact that as epr the Annual Reprot of his Minsitry for the year 2000-2001, a sum of Rs. 10.80 crore was allocated for the Scheme for Boys Hostels for the year 2000-2001 out of which only Rs. 32 lakhs ahve been spent;
- (b) if so, the reasons for such a large amount remaining unspent; and
- (c) the steps Government ahve taken to ensure that such situations do not arise in future and the amount allocated for a particular scheme is utilised to the fullest spread over the year?
