### Increase in direct tax collections

- (a) whether it is a fact that revenue of the country from direct taxes has increased during April-October 2005-06 comparing to April-October 2004-05;
- (b) if so, the percentage of increase alongwith share of increase through custom and excise; and
- (c) the extent of increase of custom through petroleum import comparing to above said period?

### **Amendment of Competition Act, 2002**
