Norms for Maximum Permissible Bank Finance

- *221. SHRI SUKHDEV SINGH LIBRA': Will the Minister of FINANCE AND COMPANY AFFAIRS be pleased to state:
- (a) whether the Reserve Bank of India has laid certain norms for fixing the MPBF for the corporate customers taking into consideration the receivables of associate group of companies like investment made by the holding companies in the associate group of companies; and
- (b) if so, what are the guidelines given to public sector banks for assessment of working capital finance of corporate customers/existing borrowers?

Utilisation of seized narcotics

- (a) whether Narcotics Control Bureau (NCB) lights up narcotics seized by it; and

Aircraft employee ratio in IA

- (a) whether it is a fact that Indian Airlines plans to shed 7,000 personnel as a cost saving measure to bring its aircraft employee ratio down to international standards;

- (c) if so, in what manner the airlines plans to achieve this and what is the time-frame for its completion?

Relocation of petrol pumps on highways

- (b) whether oil companies have expressed their difficulties to relocate the existing pumps as it will imply an expenditure of anything between Rs. 25 lakhs to Rs. 2 crores for each pump;
- (c) whether Government had convened a meeting on 5th July, 2002 with National Highways Authority of India in which oil companies were also present; and
- (d) if so, the decision taken in the meeting?

Reduction in plane fare for Tripura

- (d) the protection available for the investors from such companies; and
- (e) in what manner these companies operated with impunity despite presence of so many supervising authorities?

Problems faced by coffee growers in Karnataka

- (c) whether Government would provide an exit option to the Coffee growers in Karnataka, 98 per cent of whom are small farmers to opt for Agricultural Tax (AIT) which is more rational and quantitative?

- (a) whether Government are aware that a number of fake companies are coming into existence in the country every other day and collecting crores of rupees as security deposit from the applicants in the name of providing jobs to them;
- (b) whether Indian Informatics Infotech Private Limited, Vasant Kunj, New Delhi, also collected crores of rupees from the applicants in May, 2001 which was later on confiscated under economic offence;
- (c) whether Government would return the money to applicants from the amount confiscated;
- (d) if so, the formalities in this regard; and
- (e) if not, how would Government compensate the youths cheated by the companies?
