Operation to flush out ultras in J&K

*141. SHRI KALRAJ MISHRA: DR. AKHILESH DAS:

Will the Minister of DEFENCE be pleased to state:

- (a) whether security forces in Jammu and Kashmir have launched a drive to flush out ultras from mountain hide-outs in J&K;
- (b) if so, the number of ultras captured or killed in the operation and the arms and ammunition seized from their hide-outs, and the number of Indian security personnel who laid down their lives during the operation?

FIRs through e-mail

- *142. SHRI SATISH PRADHAN: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) whether Union Government is considering any proposal which will enable police stations to receive FIRs through e-mail from the citizens thereby bringing in transparency in the citizen-police interface in the country; and
- (b) if so, the details thereof and by when it is likely to be implemented?

Funds for Sector Reforms Scheme

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (b) if so, the details thereof and the reasons therefor; and
- (c) the steps proposed to be taken to revive the scheme at an early date?

Terrorist incidents in J&K

Will the Minister of HOME AFFAIRS be pleased to state:

(a) whether terrorist incidents have increased in Jammu and Kashmir during the last two months;

- (b) if so, whether army camps and innocent people in Jammu and Kashmir have become again the targets of terrorist activities; and
- (c) the new strategy which Government plan to adopt to counter these activities?

Activities of terrorist organisations

- (a) whether it is a fact that terrorist organisations like 'Khalistan' have recently vowed to increase their activities;

- (c) if so, the details thereof and the action the Central Government are contemplating to take in this regard?

Amarnath pilgrimage

- (c) the amount of money incurred by the Government; and

- (d) what has been the actual capacity addition upto June 15, 2003, in thermal and hydro fields; and
- (e) the steps Centre proposes to take to set certain portion for production by private sector during the Tenth Plan?

- (c) the reasons for lagging behind Australia in gold mining when both the countries have similar geographical characteristics such as rock formation and the soil beneath surface?

Studies on abnormal increase in summer temperature

 - (c) if so, the findings thereof;

(e) the action plan to save the poor people from calamity of heat wave during summer?

Power charges in States
