Implementation of power projects

*101. SHRIMATI AMBIKA SONI: DR. T. SUBBARAMI REDDY:

Will the Minister of POWER be pleased to state:

- (a) whether of the 44 power projects under implementation currently, 39 projects are slated to come up by the first year of the Eleventh Five Year Plan period;
- (b) if so, whether 5 projects are reported to be facing constraints in timely commissioning;
- (c) the total projects that are being completed within the stipulated period of time and how many will be there which will not be completed;
- (d) whether any guidelines had been issued by the Ministry of Statistics and Programme Implementation to the Ministry of Power in this regard; and
- (e) if so, what steps are being taken by the Ministry of Power to implement suggestions made by the Ministry of Statistics and Programme Implementation?

Non-utilisation of funds under SGSY

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) whether Government have failed to spend funds allocated to Sampoorna Gramin Swarozgar Yojana (SGSY);
- (b) if so, whether Centre allocated Rs. 1000 crore for the programme upto June this year which was twice the sum allocated last year, but only Rs. 469.56 crore of this was released and even paltry Rs. 61.94 crore was used;
- (c) what are the main reasons for failure in utilisation of funds under SGSY and the agencies responsible for this;
- (d) what action has been taken against the said agencies; and
- (e) what are the steps taken to fully utilize the funds allocated for SGSY during the remaining period of 2005-06?

Funds released under RGNDWM to Andhra Pradesh
