Chinese investment in infrastructure sector

- 1. SHRI MOOLCHAND MEENA: Will the Minister of COMMERCE AND INDUSTRY be pleased to state:
- (a) whether China has called for expanding bilateral ties with India in the infrastructure sector, keeping in view a spurt in East Asian countries' construction industry after its accession to the World Trade Organisation;
- (b) if so, whether China International Construction Association (CHINCA) Vice Chairman has pointed out that Chinese companies were keen to explore projects with Indian companies on BOT basis in the areas including railways, housing, hospitals and bridges;
- (c) if so, whether Government have accepted the Chinese proposal;
- (d) if so, whether any agreement has been reached; and
 - (e) if so, the details thereof?

Financial assistance to coffee growers

- (a) whether Government have extended a special financial assistance to the coffee growers to tide over the economic crisis in the sector during 2003-04;

- (d) whether any interest free loans were given by the Coffee Board in 2003-04; and

Marine exports
