- (a) whether it is a fact that there is spurt in global demand for textile items and that the small textile units are gearing up to do good business;
- (b) if so, anticipated demand of Indian textile items during next three years and likely share of small sector mills and handlooms; and
- (c) the steps taken by Government to ensure that only international standard quality items are exported to give a regular work orders to weavers and handloom houses?
