

**Subject:** Applicability of gazette Notification No.1/3/2016-PR, dated 31.01.2019 issued by the Dept of Financial Services (DFS), Ministry of Finance to the employees of Central Autonomous Bodies covered under NPS.

In continuation to this Department's earlier OM of even number dated 26.08.2021, extending the applicability of DFS's notification dated 31.01.2019, in respect of enhanced share of employers' contribution from existing 10% to 14% for the employees of Central Autonomous Bodies w.e.f 01.04.2019, the following two provisions of the notification dated 31.01.2019 which were applicable to Central Government employees only, are now being extended to the employees of Central Autonomous Bodies.

- (I) Choice of Pension Fund and investment pattern in Tier-I of NPS.
  - (II) Compensation for non-deposit or delayed deposit of contributions during 2004-2012
2. The concerned administrative Ministry/Department may consult NSDL/PFRDA, if any technical or software support is required for implementing the above provisions.
