Sir,

The Recruitment Rules for the post of Skipper were framed vide Council's letter No.14(6)/2006-Estt.IV dated 19.08.2008. As per these rules Bachelor's degree of a recognized university or equivalent is one of the prescribed qualifications for the post of Skipper in the ICAR.

As certain difficulties were being faced to recruit incumbents against this post with the qualification of graduation, it has now been decided with the approval of the Competent Authority to revise the qualification for the posts of Skipper Grade-I and Skipper Grade-II as per Annexure-I and Annexure-II.

These revised qualifications come into force with immediate effect.
