Dear Cir/Madam,

As you are aware, Government of India has declared 15th November, the birth anniversary of Bhagwan Birsa Munda, the legendary freedom fighter and tribal leader of the country, as Janjatiya Gaurav Diwas to commemorate the contributions of tribal communities in national history and culture, and motivate the coming generations for protecting our cultural heritage and national pride. This day also honours all the tribal freedom fighters and strengthens our resolve for achieving socio-economic development of the tribal population. along with preserving and promoting their rich and diverse cultural heritage. This year, it being the culmination of the 150th Birth Anniversary of the Bhagwan Birsa Munda on 15.11.2025. Ministry of Tribal Affairs has decided to celebrate the 5th Janjatiya Gaurav Divas 2025 as a commemorative event in the central and every states/UTs during the period commencing from 1st November, 2025 and culminating on 15th November, 2025. Celebration of the main commemorative event at the national level would be led by the Ministry of Culture and the Hon'ble Prime Minister is expected to grace the grand event on 15.11.2025. All the States /UTs must organize commemorative event simultaneously in the State capital and also in the districts respectively. The event is expected to be connected through a two-way connectivity to the States/UTs Events and District events.

- As one of the Minstries/Departments implementing schemes with ST Component, you are one of the stakeholders in ST welfare and development. Therefore, it is requested to participate in the celebrations of the Janjatiya Gaurav Diwas by undertaking such activities as (i) inauguration or foundation stone laying for infrastructure projects or disbursal of benefits targeting the tribal population undertaken with STC funds; (ii) launch of initiatives/schemes (iii) capacity building activities for sector specific matters oriented towards tribal population (iv) public awareness campaigns in areas with predominantly tribal population on various schemes and other initiatives of your Ministry/Department to enable them to benefits from the scheme; (v) documentation of best practices, success stories, innovative initiatives, digitization and database management (vi) maintenance of disaggregated data of ST beneficiaries of schemes and analysis thereof so as to ensure that the benefits reach them and (vii) any other initiative/activity that the Ministry/Department may find fit to be taken up under the Janjatiya Diwas celebrations. This will ensure that adoption of the whole of government and whole of India approach in tribal welfare and development.
- 3. You are also requested to instruct offices and other institutions under your control to celebrate the day fittingly, so as to make this day one of commemoration of the tribal freedom fighters as well as of public celebrations of their contributions to the freedom movement in particular and the tribal communities to Indian society and heritage in general, leading to inclusive development, empowerment and upliftment of tribal communities.

- 4. Further, a Nodal Officer from your Ministry/Department may be appointed at the level of Director to coordinate with the MoTA for the celebrations/programmes during JJGD. A Calendar of events/ activities to be taken up during this commemorative event may be prepared and the same may be shared with us for information. The Nodal officer is responsible to ensure furnishing of proper report and documentation of the event/activities organized and conducted by your Ministry/Department and uploading of the same in the portal of the MoTA.
