  - vi) A copy of the Annual Report for the year 2017-18 indicating policy decisions and the activities undertaken by the Ministry/Department for the benefits of persons with disabilities.

  3. **All the Ministries/Departments are requested to send a both Soft copy and Hard copy of the matter for inclusion in the Annual Report 2017-2018 in English and Hindi through E-mail/CD or Hard copy is well. The Hindi typed matter should be in Kruti Font, so we can translate easily into the Printed Software.**
