Subject: Inviting applications for the ICAR Emeritus Professor Scheme.

Sir,

As you are aware that the Council is implementing a scheme of Emeritus Professor (EP) in the field of Agriculture and Allied Sciences to be located at ICAR Institutes, State Agricultural Universities/ ICAR-DUs/ CAUs/ CUs with agriculture faculty/ Centre and State funded Institutions/Organization under National Agricultural Research Education System (NARES) as per guidelines of the Scheme (available on **ICAR website www.icar.org.in**).

The ICAR- Emeritus Professor scheme aims to utilize the talent and services of outstanding superannuated scientist/ teachers from NARES in teaching UG/PG courses, other related activities and developing instructional material/ text Books including e-learning resources for use in national agricultural education programme and distance education.

Presently, 20 slots of Emeritus Professors are to be filled up, for which, the applications are invited from superannuated/superannuating scientist of repute of the level of Principal Scientist/Professor and above from NARES in the field of Agriculture and Allied Sciences.

The benefit of the scheme shall be open to all the Principal Scientists and above and also the faculty members of equivalent position including teachers of repute who are physically fit and mentally alert. The applicants having one year of service left or superannuated before one year from the last working day of the month of notification (**i.e. 30th June, 2025**) will only be eligible for consideration under this scheme. Applications submitted through the executive authority of the Institution where the Emeritus Professor proposes to carry out the work and are duly recommended with justification will only be considered.

The eligible candidates may apply in the prescribed Proforma attached for **Emeritus Professor Scheme** by **July 31, 2025 to ADG (HRD) at adg.hrd.applications@gmail.com**, mentioning the "Application for **Emeritus Professor Scheme**. Name of Applicant and contact number" in the subject line of the email. You are requested to bring this to the notice of all eligible Scientists/Professors and sponsor one or two candidates.

Last date for submission of the application is July 31, 2025.
