Subject: Grant of Financial Assistance to the Scientific Organisations during the year 2019-2020.

The Indian Council of Agricultural Research (ICAR) is continuing its scheme for grant of partial financial assistance to scientific/professional societies and public/quasi-public bodies engaged in the field of agriculture, animal sciences and subjects of allied nature, for organizing the International/National Conference/Symposia/Seminar etc., and the publication of Scientific Journals etc. as per the rules framed by the Council specifically for the purpose during the financial year 2019-2020.

- 2. Eligible Scientific Organizations/ Societies/ Bodies may send one copy of the application in the proforma available on ICAR website https://icar.gov.in/content/revised-rules-and-guidelines-grant-financial-assistance-societies for organizing International/ National Conference/ Symposia/ Seminar etc., and one copy of application for publication of Scientific Journals with the latest issue alongwith the following documents:
 - i) Certificate of Registration as a Society.
 - ii) Memorandum of Association of the Society/Association
 - iii) Rules/Articles of Association of the Society/Association
 - iv) List of members of the Society/Association as on the 31st March, 2019 and the organization in which they are serving.
 - v) Two copies of the Audited Utilization Certificate for the last grant received, if any, from the ICAR, duly signed by the Chartered Accountant & Secretary / President of the society alongwith the official seal.

All applications received by the specified time will be considered by the Standing Committee in its next meeting. The societies may provide Bank details alongwith application for online payment in the given format: -

3. Attention is invited to the following decision of the Standing Committee: -

- i) For International Conference/ Symposia/ Seminar etc., the organization must obtain and provide approval of the Nodal Ministry/Department, Ministry of External Affairs and Ministry of Home Affairs at the earliest. Without these approvals, sanction orders, even after the approval of the Standing Committee, grants will not be released.
- ii) After organizing the event, all Societies are required to submit their recommendations of International/National Conference/ Symposia/ Seminar etc., and feedback report in a prescribed proforma (https://icar.gov.in/content/revised-rules-and-guidelines-grant-financial-assistance-societies) alongwith proceedings.
- iii) The Council will also depute its nominees to attend such Conference/ Symposia/ Seminar etc., who will be registered by the Societies free of any charges.
- iv) Only such Societies which have been approved by the Standing Committee will get the financial assistance for publication of Journal on the basis of rating given by NAAS. The other societies will not be eligible for award of publication grant from the Council.
- v) The copies of the proceedings of Conference/ Symposia/ Seminar etc., and latest publication of Journal for which ICAR has provided assistance should be invariably sent to the undersigned to the Chief Librarian, ICAR Library, Krishi Bhavan, New Delhi for documentation.
- vi) The Societies should send a copy of the latest Journal and Proceedings of Conference/ Symposia/ Seminar etc., free of cost to selected audience, academic councils, extension agencies and ICAR library under intimation to the undersigned.
- vii) The societies whose publication of Journal is more than twelve months behind the schedule, will not be considered for financial assistance.

viii) The recipient will have to provide 50% of the expenditure incurred on the publication of their Journal as matching grant.
