Sub: Request from Directors of Institutes to relax the power for sanction of honorarium to themselves from Rs. One Lakh Per Annum to a higher limit- Regarding.

Sir,

The above issue was raised in the Directors Conference held on 8th & 9th March, 2018.

IPTM Unit examined the issue and the existing guidelines/procedures, viz. (para 1.3.19.1 & 1.3.19.2 of ICAR Rules and Guidelines for Professional Service Functions (Training, Consultancy, Contract Research and Contract Service), reproduced below were found to be sufficient:

- 1.3.19.1 All cases of annual benefit sharing payments over and above Rs.10 lakhs per annum to an individual shall be considered only if full justification is provided by the Institute/SMD. Otherwise, any such amount exceeding the Rs.10 lakhs limit shall be counted as brand value of the ICAR system to be credited to the account of Institutional Income.
- 1.3.19.2 Directors of the Institutes are empowered to sanction to themselves up to Rs. One lakh per annum of such benefit sharing payments. However, for any payments more then Rs. One lakh per annum and upto Rs Ten lakh per annum, the approval of the Director General, ICAR shall be required. Payments above Rs. Ten lakhs to Directors of Institute shall be governed by para 1.3.19.1 of ICAR rules & guidelines referred above.

A proforma has also been enclosed for use by concerned SMD while seeking approval of the Council for grant of Honorarium to the Directors of the Institute over Rs.1.00 lakh & above per annum as benefit sharing.
