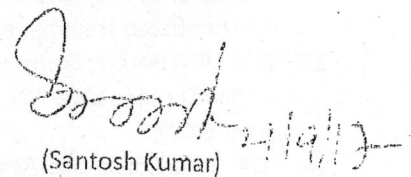
Subject: Quarterly Training plan for the months of October, November and December 2017 on EAT Module of PFMS for Central Sector Schemes and Centrally Sponsored Schemes at INGAF/RTCs/SPMUs.

With reference to the letter DO. No. 21011/INGAF/PFMS/HQ/35/17-18/348 dated 7th September 2017 and for implementation of PFMS in all Central Sector Schemes and Centrally sponsored schemes of IWMP, NRHM and RUSA it is decided to organize trainings on EAT Module of PFMS in the month of October, November and December at INGAF/RTCs/SPMUs.

Beside the trainings mentioned in the Annexure A, all Pr. CCAs/CCA/CA with independent charge are requested to organize as many trainings for implementing agencies of their respective Ministries/Departments as possible. In case additional trainings for particular Ministry/Department are required to be conducted by training wing of PFMS, request for the same may be sent at the earliest. It would be the responsibility of the concerned Pr.CCA/CCA/CA to ensure adequate participation in the trainings being organized in the states for respective Central Agencies in consultation with concerned SNOs.

All the SNOs are requested to conduct trainings for the implementing agencies of Centrally Sponsored Schemes and Central Sector Schemes located in their respective states in consultation with Pr.CCA/CCA/CA of the concerned Ministries. At least 15 training programs per month (October to December 2017) are to be conducted by every SPMU. Indicative dates and contact details for these trainings have been mentioned in the Annexure B and Annexure E respectively. However the SPMUs may readjust the dates in consultation with the line Ministry/Department and as per availability of logistic facility. SPMUs are also requested to extend necessary support including trainers for the trainings to be conducted in the respective states by various Departments. Venues and Contact details of resource persons are mentioned in Annexure-C and Annexure-D respectively.

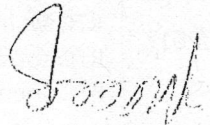

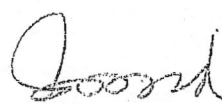
