## Subject: Recruitment to the post of Technician (T-1) and Technical Assistant (T-3)regarding. Sir/Madam.

## The Council vide letter Nos. F. 33(6)/2015 – Estt.I dated 28.7.2015 had requested all the Directors of ICAR Research Institutes/PDs/NRCs/Bureaus/ZCUs to put on hold or cancel all the recruitment process already initiated for filling up the above mentioned posts. Thereafter, the Technical Service Division vide e-mail dated 30/10/2015 had requested all institutes to keep the vacancy position, reservation position for SC/ST/OBC/PWD categories (Functional Group-wise) ready for notification and advertisement for filling up the above mentioned posts at a very short notice. Briefly speaking, the institutes have been asked to be in a state of preparedness for conducting the examination.

Keeping in view the decision of GB in its meeting held on 26/6/15 and the fact that the Directors of the Institutes are the appropriate prescribed authorities for carrying out the recruitment process, they are requested to initiate the process of examination by advertising the vacancy in the Employment News/local dailies etc. as per GOI guidelines. The advertisements by the Institutes having requisite vacancies may be completed by **31/12/2015**. Those institutes which fail to advertise the vacancies by the stipulated date i.e. 31/12/2015 will not be considered for centralized examination scheduled to be held during 2016.

The total number of applications received by the institutes in response to their advertisement in the Employment News/local dailies will be compiled by the ICAR Hqrs. for printing the question booklets and OMR sheets. For this purpose the institutes will have to report the ICAR Hqrs. by **6<sup>th</sup> February, 2016**. The Question Papers and OMR sheets will be supplied by the Council. The date of the exams will be intimated in due course. Accordingly, the institutes will intimate date of examination to the candidates by issuing admit card etc. Needless to say the fair conduct of the exam would be the sole responsibility of the Director of the Institute. The requisite number of Question Papers and OMR-Type answer sheets would be handed over to the Director or his authorized representative from each Institutes/PDs/NRCs/Bureaus/ZCUs unit.

Consequent to this notification all earlier recruitment action for the posts of Technician (T-1) and Technical Assistant (T-3) may be cancelled.
