**Subject: Curtailment of 110<sup>th</sup> FOCARS training- reg.**

Sir,

In view of emergency situation prevalent in the country due to Pandemic COVID-19 (Corona) and orders of Chief Secretary, Telangana, for requisition of 200 beds in NAARM, Hyderabad, it has been decided by the Competent Authority that :

- (i) Training of Scientists Probationers is curtailed with immediate effect and they may be relieved from NAARM, Hyderabad, immediately.
- (ii) Their postings shall be decided in due course through online module to be opened on 23<sup>th</sup> March, 2020. Posting Orders shall be issued through e-mail to you and to probationers.
- (iii) The intervening period between the relieving and posting, the probationer scientist may decide to go at the place of their choice.
- (iv) The TA/DA as applicable from their choice of place for stay to place of posting shall be provided by the Institute concerned where they will be posted. No new joining time or TTA etc. shall be applicable except for the usual journey time or unavailed journey time.

This issues with the approval of the Competent Authority of ICAR as a special case.
