Following are the Terms of references (Outcome Review of Schemes) of the Committee

The focus of the committee to review the outcome/impact of various Schemes of ICAR system on the following issues:

- 1. Whether the existing schemes are fulfilling the mandate of ICAR in broader sense particularly with reference to the following:
- a. Whether the schemes are addressing the problems being faced by the farming community in terms of coping with diseases, droughts, floods etc.
- b. Whether the schemes are progressing so as to get higher production/productivity/profitability to farmers practicing in the areas of crops, fisheries, animal, horticulture, etc.
- c. Whether the schemes are being run to achieve the over-all goal of having sustainable food and nutrition security of the country.
- d. Whether schemes are working towards reducing operational hardships of the farmers, and
- e. Whether the schemes have contributed or are contributing in generating Export Potential of Indian Agricultural products (in terms of crops commodities, fisheries/animal products etc.)
- 2. Whether these scheme are functioning as per their respective mandate/objectives.
- 3. Whether the schemes have achieved significant outcomes consistent with their objectives/targets.
- 4. Whether the objectives of schemes in the broader sense do not over-lap with those being run by other central funded organizations.

- 5. Whether the schemes have contributed significantly in terms of genetic improvement/ germplasm collection/ agriculture technologies, seed stocks/ quality planting material etc.
- 6. Whether the schemes are generating Intellectual Property to the extent of spending of the public funds.
- 7. Whether the existing schemes have rigorous targets to be achieved.
- 8. What methods of concurrent and post implementation of evaluation of outcome schemes is being followed.
