Application for appointment of Research Associates on contractual basis in Agricultural Education Division of ICAR

Applications are invited for walk-in-interview on 01/10/2018 at 10.00 a.m. for five post of Research Associates (RA) purely on contractual basis, in the Agril. Education Division, KAB-II, Pusa, New Delhi from eligible candidates having Doctoral degree in any branch of agricultural/veterinary/related allied Sciences or Masters degree with 4 years/5 years of Bachelor's degree having 1st division or 60% marks or equivalent overall grade point average with at least two years of research experience as evidenced from Fellowship/Associate-ship/Training/other engagements. Knowledge of computer operation is essential. Published research papers will be desirable. It may be noted that:

- 1) No TA/DA will be given to the Candidates for attending the interview.
- 2) The upper age limit is 40 years for men and 45 years for women.
- 3) Candidates reporting after 10.30 a.m. shall not be interviewed.

Emoluments: for Masters degree holders, Rs. 38,000/- per month and for Doctoral degree holders Rs. 40,000/- per month consolidated plus HRA as admissible based on the revised guidelines of the Council's O.M. No. Edn. 6/27/2014/HRD dated the 13th July, 2015.

Other Terms & Conditions:

- i. **Age limit:** Maximum age is 40 years for RA (age relaxation of five years for SC/ST & women and three years for OBC).
- ii. RAs are full time workers and are required to adhere to the administrative, financial and disciplinary regulations of the Council/Agril.Education Division, where the incumbent is working.
- iii. If any RA leaves his/her assignment without permission for one month, he/she will stand terminated from the date of his/her absence.
- iv. Since RA are engaged for the Scheme work full time, the RAs will not be allowed to do any other work or to accept or hold another appointment with or without remuneration elsewhere.

- v. The candidates will have to compulsorily bring the filled in application form (as per the format annexed), all the original certificates from matriculation onwards, Date of birth certificate, NET/equivalent certificate, degree certificate either original or provisional and one set of the self-attested photocopies of all the required certificate from matriculation onwards and an attested copy of recent passport size photograph pasted onto the application form. Proof of experience and publications also need to be submitted.
- iii. No TA/DA will be paid for attending the interview.
- iv. Only the candidates meeting essential qualifications would be interviewed.
- v. Concealing of facts or canvassing in any form shall lead to disqualification or termination of such candidates.
- vi. The RAs shall have no legal right to claim his/her regularization/appointment by absorption or otherwise against any regular posts or any further contractual engagement on termination of scheme/ project. The engagement in the scheme is purely time-bound, non-regular and co-terminus basis with the scheme. The services of the incumbent shall stand terminated automatically on expiry of period given in the sanction may be extended in the interest of schemes/projects.
- vii. The tenure of RAs will **initially from 01.11.2018 to 31.10.2019 which may be** extended based on requirement and satisfactory performance of incumbents.
- viii. The candidates have to strictly submit the form annexed (typed/filled) duly signed and submit on the date of interview.
