## <u>ORDER</u>

In exercise of the powers conferred by the Central Government Vide Notification No. S.O.1994(E) dated 7th Aug., 2008 of the Ministry of Labour & Employment, the undersigned hereby revise the rates of Variable Dearness Allowance for the employees engaged in "Employment of Sweeping and excluding activities prohibited under the Cleaning Employment of Manual Scavengers and Construction of Dry Latrines (Prohibition) Act, 1993"w.e.f. 31.12.2013 on the basis of rise in the average consumer price index number reaching 238.83 from 225.05 (Base 2001 - 100) and thereby resulting in an increase of 13.78 points calculated on the basis of average for the period of six months ending on 31.12.2013. The revised rates of Variable Dearness Allowance w.e.f. 01.04.2014 shall be as under:-
