Subject: Amendment in Recruitment Rules of the administrative posts (Group 'C' posts) i.e LDC and Stenographer Grade-III filled through direct recruitment in ICAR System - reg.

Sir/Madam,

The Recruitment Rules for post of LDC and Stenographer grade-III were circulated vide letter no. 14(1)/2008-Estt-I dated 8-06-2011. The Column No. 5 & 12 in the aforesaid Recruitment Rules pertains to Age limit & reservation status for direct recruitment respectively.

The DOPT's O.M No. 36035/3/2004-Estt-(Res) dated 29-12-2005 provides that 3% of vacancy (ies) in direct recruitment quota are supposed to be reserved for Persons With Disabilities (PwD) and the Department of Personnel and Administrative Reforms OM No. 39016.10.79 Estt-(c)dated 15-12-1979 provides that 10% of posts in Group C (including the erstwhile group D post) are to be reserved for ex-servicemen as defined in the said OM. Both these categories i.e. PwD and Ex-servicemen are eligible for relaxation in age on direct recruitment in terms of the guidelines issued by the DOPT as amended from time to time.

Keeping in view the above provisions it has been decided with the approval of the Competent Authority to incorporate the above provisions in the Recruitment Rules of the aforesaid post against Column no. 5 & 12. Accordingly Column 5&12 of the recruitment rules would now be as follows:
