A number of issues have been raised during the last 5 years of the implementation of the RTI Act, 2005. One of these is the need for an identity for RTI. In this endeavour the Government of India has got a simple iconic LOGO designed for RTI. A copy of the guidelines for use of the logo and two Tin Plates with the logo printed on them are being attached with this letter as a sample. It is requested that this logo may be displayed at all places where an applicant may file an RTI application. It may also be displayed on all Government stationery.

2. 2 mounted posters on RTI are also enclosed. The Posters on Right to Information may be displayed at prominent places of Ministries/Departments.

3. Government of India has also launched a comprehensive knowledge portal on RTI <u>www.rtigateway.org.in</u>. The portal is a one stop knowledge bank for information seekers, information providers, trainers, Information Commissions, students and academicians. It provides for a digital library, discussion fora enewsletter and a-blog. Latest judgements of the High Court and Information Commissions, reports, articles, guides, manuals, handbooks for various stakeholders, online certificate course are also available on this portal. There is a facility for stakeholders to interact through a dedicated and open discussion forum and to register as resource persons.
