Subject: Domestic Corporate deal between Jet Airways and ICAR – Membership regarding.

Indian Council of Agricultural Research (ICAR) has become the member of Domestic Corporate deal of Jet Airways initially for a period from 1-1-2008 to 31-3-2008, which can be further extendable.

COVERAGE AND INCENTIVE OFFER

- 1. The entire domestic Network of Jet Airways including Colombo and Kathmandu will be covered under the scheme.
- 2. The total air travel business generated by ICAR on Jet Airways for entire period of contract would be taken into account.
- 3. Incentives are calculated on the domestic net billing which means the total value of flown revenue on Jet Airways' domestic flights and Jet Airways' flights to Kathmandu and Colombo (i.e. gross airfare MINUS taxes like Inland Air Travel Taxes and the Passenger Service Fees, Insurance Surcharge or any other tax or surcharge levied on such tickets).
- 4. Only normal full fare tickets, check fares, one fare pass and corporate one fare pass, web fares will be considered for the purpose of determining Net Billing. 'W', 'V' & 'O' Class fares will not be considered for the purpose of determining Net Billing.
- 5. ICAR shall control this Scheme for all its Institutes from Hqrs. at Krishi Bhavan, New Delhi.
- 6. The incentive will be paid on pro-rata basis i.e. ICAR will earn 2 to 6% incentive commission on different slabs of net domestic billings.
- 7. The incentive would be paid by means of cheque. The incentive cheques would be issued in favour of Secretary, ICAR.
- 8. The DEAL CODE assigned to ICAR is **9W3477002**

METHODOLOGY

Officers of ICAR and non official members/Experts called at the expense of ICAR will have to travel as per existing instructions of Ministry of Finance.

By following the instructions of Ministry of Finance, if tickets are booked on Jet Airways', it must be ensured that DEAL CODE is reflected in the right hand corner of tour code box of all tickets or in the corporate code box for web fares. Whenever computerized tickets are issued by travel agents, they would be instructed to incorporate the DEAL CODE on the tickets with the input **9W3477002**, for easy tracking of the corporate travel.
It is specifically understood that only the tickets i.e. Jet Airways'

3. It is specifically understood that only the tickets i.e. Jet Airways' documents issued and sold within India, bearing the deal code will be eligible for payment of incentives by Jet Airways'. As such it is mandatory to check the DEAL CODE is reflected in the Endorsement Box of the tickets issued by Jet Airways'.

 - Assistance through corporate help desk will be provided at Airports. It could be special handling of passenger in the form of approved excess baggage waiver, approved upgrades etc. wherever possible but cannot be claimed as a matter of right.
