In exercise of the powers conferred by the Central Government Vide Notification No. S.O.1994(E) dated 7th Aug., 2008 of the Ministry of Labour & Employment, the undersigned hereby revise the rates of Variable Dearness Allowance for the employees engaged in "Employment of Sweeping and Cleaning excluding activities prohibited under the Employment of Manual Scavengers and Construction of Dry Latrines (Prohibition) Act, 1993"w.e.f. 31.12.2014 on the basis of rise in the average consumer price index number reaching 252.83 from 241 (Base 2001 - 100) and thereby resulting in an increase of 11.83 points calculated on the basis of average for the period of six months ending on 31.12.2014 The revised rates of Variable Dearness Allowance w.e.f. 01.04.2015 shall be as under:-
