CIRCULAR

This has reference to Council's earlier circular of even number dated 15.12.2016, on the subject of cashless/digital transactions in ICAR system.

In supersession of Council's aforesaid circular, following instructions are given for strict compliance. In order to scrupulously implement the above system in ICAR, a Performa is enclosed herewith .Information in the prescribed proforma shall be sent to Dr. S.P. Kimothi, ADG (TC) (e-mail ID- adgcoordination@gmail.com) on day to day basis. The following points may also be kept in view to effect compliance in the above matter:

- i) As per the directives of Cabinet Secretariat (Copy enclosed), all payments and receipts may be done only through digital options.
- ii) Swipe machines and prepaid cards be arranged from the Banker of your Institute immediately.
- iii) You should avail the facilities like e-wallets for cashless transactions within the shortest possible period.
- iv) Further, Ministry of Finance vide its O.M. dated 05.12.2016 regarding payment to Suppliers etc. by Government Departments through e-payment (Copy enclosed), has inter-alia instructed that "All Ministries/Departments of the government of India shall ensure with immediate effect that all payments above Rs.5000/- (Rupees Five Thousand Only) to suppliers, contractors, grantee/loanee institutions etc. are made by issue of payment advices only".
- v) The above instructions of Ministry of Finance are for payments. As regards, receipts from various sources, efforts should be made to switch over to complete cashless transactions as far as possible.

In view of above, it is requested that Directors of ICAR Institutes may personally monitor the progress and send the report as per the Performa on day to day basis/weekly report for further necessary action.

Dear Semetary,

The Demonetization decision presents an opportunity to transform India into a less cash economy. Educating all segments of the population on its utility and empowering them in the use of digital means for financial transactions is an important step in this direction. This would require the active support of State Governments as well as effective leveraging of Central Government organizations across the country. This would also promote efficiency and transparency in the system. I request you to lead the efforts in this regard in your Ministry.

2. Various digital options are available to address the requirements of different segments of the society, such as,

- i) For people who do not have mobile phones, Aadhaar Enabled Payment System (AEPS) makes it possible to transact with Aadhaar based authentication. Prepaid/debit cards and Banking correspondents also provide the required services.
- ii) For people having generic phones, USSD (*99#) facilitates digital transactions on mobile phones through SMS.
- iii) For smart phone holders, Unified Payment Interface (UPI) facilitates transactions through bank accounts.
- iv) For computer literate population, Net Banking is available.

4. I would request you to draw up an Action Plan to involve the officers and staff of your Department, Attached Offices and PSUs for promotion of digital payments. You may consider incorporating the following initiatives to achieve the desired goals:

- i) All payments and receipts of your Department may be done only through digital options.
- ii) Specific targets may be laid down for on boarding your target groups and beneficiaries and the progress be monitored on a regular basis.
- iii) Massive campaign may be launched among your target groups and beneficiaries. Awareness material has been uploaded on NITI Aayog's website (http://niti.gov.in/content/digital-payments).
- iv) The target groups, beneficiaries etc., coming into contact with the functionaries of your Department may be enabled to transact digitally. Field functionaries may be encouraged to handhold the members of public to onboard them onto the digital platform.

 v) Training and awareness camps may be organized for the general public involving Banks, Corporates, Self Help Groups, NGOs etc. to train the targeted population in using digital options.
/ CSR funds could also be utilized for this purpose.

Subject: Payment to Suppliers etc. by Government Departments through e-Payment

A reference is invited to this office O.M. No. 1(1)/2011/TA/366 dated 1st August 2016 regarding payment to Suppliers etc. above Rs. 10,000/- by Government Departments through e-Payment.

2. In order to attain the goal of complete digitization of Government payments, the existing limit of Rs. 10,000/- prescribed in paragraph 2 of this office O.M. dated 1st August 2016 has been further reviewed. It has now been decided to lower the threshold limit to Rs. 5,000/-(Rupees five thousand only).

3. All Ministries/ Departments of the Government of India shall ensure with immediate effect that all payments above Rs. 5,000/- (Rupees five thousand only) to suppliers, contractors, grantee/loanee institutions etc. are made by issue of payment advices only.
