

2. This proposal has been examined by Deptt. of Expenditure. It is reiterated that a detailed proposal may be sent for enhancing the retirement age of only a small percentage of the total strength of the scientists of ICAR for only those involved in teaching and that too should be considered on a case to case basis based on the need to retain the teaching faculty. The financial implications that the proposal would entail should also be indicated.
