4.	The awardees will be identified by nomination alone, for which science academies, both agricultural and non-agricultural, universities and other eminent scientists will be approached by ICAR.	The applicant for this award should necessarily be nominated by the President of Science Academies or Vice Chancellors of Agricultural Universities or Directors of Institutes.
5.	The research work should be defined by its originality in thinking, its path-breaking nature, and its high potential value for the future.	The research work should be defined by its originality in thinking, its path-breaking nature, and its high potential value for the future. The person nominated should have made significant innovation which could have considerable socio-economic and environmental impact.
